This proceeding was heard on 7 March 2017 at Auckland before the Honourable Justice Edwards, who having heard from Paul David QC for the plaintiff, and having read the evidence adduced, and there being no appearance, or statement of defence or other document filed by the defendant, gives judgment for the plaintiff against the defendant as follows:

1. Judgment on the plaintiff's first claim against the defendant for the payment of the outstanding debt in the sum of US \$6,404,238.
2. Judgment on the plaintiff's second claim against the defendant for payment of the indemnity sum of US \$462,471.
3. Interest on both sums being US \$36,498.50.
4. The defendant is to pay the plaintiff's costs of NZD \$85,000 together with disbursements of NZD \$14,729.73.
